- 1 Call to order-6:00 PM
- 2. Flag Salute
- 3 Moment of Silence- In remembrance of 9/11
- **4. Roll Call-** Board Secretary, Val Chappell called the Roll. Commissioners Young, Ingram, and Jones were present as was Chief Mike Brown. Trevor Severance from West Mason was also present.
