- 1 Call to order-6:01 PM
2. Flag Salute
3. **Roll Call-** Board Secretary, Val Chappell called the Roll. Commissioners Young, Ingram, and Jones were present as was Chief Mike Brown.
4. **Approval of minutes.** A motion was made by Commissioner Nick Jones to approve the minutes from September 11, 2024. Commissioner Steve Ingram seconded the motion. The vote carried unanimously.

 - d. Commissioner Young commented that Sat.(the Pig Roast) was outstanding.
